CAPITAL & FINANCIAL SERVICES LIMITED** ("the Company") for the quarter and nine months ended 31st December 2025 attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the Regulation") as amended.
